

## **SECRETARY REPORT FROM 23.12.2017 to 27.01.18**

### **Meeting with CCL:**

**23.12.17:** President, Sri H.P.Biyani & Sri Rajiv Biyani met Mr. A.L.Thackkar, Chief Coordinator, Computer cell at CCL and enquired about the notices issued to consumers to deposit amount against TCS with interest from 2012-13 to July-2017. Mr. Thackkar informed that CCL has submitted Form no. 27 C towards TCS to the Income Tax department every year in time, but have been rejected by the TDS Circle, Ranchi on some arbitrary ground. He however, assured that CCL have made an appeal before the IT department at Patna and awaiting hearing on the same.

**02.01.2018:** President & Mr. H.P.Biyani met Sri D.K.Ghosh, Director Finance, G.M.(S&M) and other senior sales officer of CCL and discussed the matter at length on following points.

The DF admitted that TCS levied on coal consuming units is not justified and CCL has appealed before the Chief Commissioner, IT, Patna but hearing is awaited. CCL would request all MSME units to obtain certificate from the IT department as coal consumer, for which Form 27C have been submitted by CCL.

As regards supply of coal from one source, DF advised concerned officer to ensure supply of coal to units having coal quota < 300Mt. He also directed GM to ensure timely issue of coal delivery orders.

It was also decided to allot good quality coal to Refractory units from Inclined pit of Bhurkunda Mines under Argada Area.

As regards quality of coal confirming to its GCV, DF assured to take action soon. Besides levy of Rs.50/- per M.T.as Evacuation Facility charges would continue to compensate loss of CCL.

### **Seminar on Low Cost Automation:**

**27.12.17 & 28.12.17:** Two days workshop was conducted by JSIA in association with GIZ, New Delhi on Low cost Automation & Quick changeover Techniques at JSIA Hall from 10.30A. to 5.30 P.M. on both days.

Mr. Gautam Doshi, Advisor, IMTMA gave power point presentation on concept of low cost Automation, Mechanism & Mechanical elements of automation. He also deliberated on economic justification of automation and automation system integration. The influence of set up time & Idle time was well presented thru video clippings. The participants were also apprised on benefits of quick changeover in their units.

Mr Naresh Khantoor, Managing Director, Econ System, Gurgaon spoke about three stages of Poka Yoke, ( Signal warning, Physical barriers, & Total prevention). The concept of OEE (Overall Equipment Efficiency) is very important for every industries, as most Indian companies operate only at 41% of their time availability and how to improve OEE in the industry. Mr. Khanatoor also talked about sensors ( PLC/SCAD) for automation and its various applications. He also dwelled on Pick & Place Robots & its integration in the industries and presented many videos on the project. He further mentioned that Robot alone is not enough, but important auxiliaries are to be considered while selecting Robotic project for automation. Finally he advised to chose appropriate automation best suitable for the plant.

The seminar was attended by President, VP, Hony Secretary, Treasurer, Jt Secretary, Mr. Philp Mathew, Mr Nishant Prakash, Mr. Pawan Kanoi and few other participants from our member units & 8/10 students of JMSMETR. We regret that despite their confirmation many members could not attend the important seminar due to reasons best known to them.

Being a whole day workshop, business lunch was provided to all participants & the faculties on both days.

**18.01.18:** President & Hony Secretary met Sri Abhay Kumar, E.E.E. Ranchi East circle, at his office at Kusai colony, Doranda. Discussion was held to finalize pending applications for remission of 25% on Fixed charges for the period 2004 to 2010 and payment of interest thereof. Sri Abhay Kumar directed his concerned accountant to settle the matter. All pending applications were cleared by EEE for release of payment.

#### **Workshop with CBEC on E-Way bill:**

**19.01.18:** A workshop was organized by Central Board of Excise & Customs at JSIA from 4:00 P.M. to 6:30P.M. on E-Way Bill, Export, Refund, Job Work & outreach. Sri Rajesh Toppo & Sri Sanjit Modak gave P.P. presentation on registration & Generation of E-way bill which would come into force in Jharkhand from 1<sup>st</sup> Feb.'18. E-Way bill would be mandatory for supply of goods & services above Rs 50,000/- through out the country. It was mentioned that no e-way bill would be required for nil rated goods. They also clarified queries on export of goods & refund procedures under GST ambit.

More than 40 members & representatives from the Firm participated in the workshop & benefited on recent updated on GST.

The workshop was followed by High tea.

**Meeting on EoDB with D.C., Ranchi :**

**19.01.18:** Sri Kamal Agrawal attended a meeting chaired by Sri Manoj Kumar, Dy. Commissioner, Ranchi amidst presence of representatives from many departments viz: Pollution Board, Electricity, RIADA, Labour, DIC & other stake holders viz. Hindalco, HEC, & units from MSME sector, during a workshop on face to face connect with Investors under EoDB. Discussions were held on following issues:

1. Many industries had filed complains under Single Window to which DC sought clarification from the officers of the department & directed them to resolve the issues at the earliest.
2. Matter of tripping & shut down of electricity in Industrial area was discussed, upon which DC directed to ensure continuous supply of power to industries.
3. Face to face to discussion was held on pending cases of renewal of CTO from Pollution department. The officers from Board assured timely release of CTO/CTE.
4. Sri Adarsh Ramsisaria , representing his unit, requested DC for use of Fly Ash bricks on experimental basis in the construction of Buildings & Toilets by the Govt. departments. DC assured that MSMEs registered under GeM would get orders from the department.
5. Sri Kamal Agrawal raised the matter of up keep of Roads, Drains in Namkom Industrial area and said that road in front of Premsons Motor is full of pot holes which always remain filled with dirty water. RIADA officers assured to take immediate action on that.

Water booths are operational at PF-1 & 2 at Hatia Station by Social Groups.
- 3) High level platforms are constructed at Tatisilwai, Gangaghat, Gautamdhara, Silli, Kita, Tulin, iloo, Torang etc.
- 4) Regular Summer Internship for Engineering and MBA students are conducted by Railways.
- 5) Online booking of retiring rooms, Dormitory is operational at Ranchi. Hatia and Muri through Railway site. It can be done through IRCTC website also.
- 6) OBHS Services are available in 19 trains starting from Ranchi & Hatia.
