

## **SECRETARY REPORT FROM 29.01.2018 to 17.03.2018.**

### **Meeting with Principal Secretary ,Industries & Mines & geology:**

**31.01.18:** A meeting was organized with Industries department at JSIA at 5:00 pm where Sri S.K.Burnwal, Principal Secretary to CM & Secretary Industries, Mines & Geology, Sri K.Ravi kumar, Director Industries, Sri Ajay Kr. Singh, Regional Director, JIADA & other officers from JIADA & Industries department were present to have interaction with members on problems related to industries.

Sri Arun Khemka , PP welcome the dignitaries and anchored the program.

President JSIA gave welcome address and Hony Secretary gave power point presentation on issues related to, JIIPP, RIADA, Procurement Policy, Electricity, Commercial Tax, Mines & Minerals, Pollution, Poultry & Hatchery.

Sri S.K.Burnwal appreciated the presentation and interacted on each & every point of related issues.

On provisions of JIIPP he accepted JSIA's suggestions to modify the clauses of Modernization & Expansion of the policy for existing MSME and directed DI to incorporate changes as suggested.

On demand he agreed that the henceforth all payment of RIADA would be made on line. He directed Sri Sunil Singh, Secretary, RIADA to upload details of all dues on its portal for view and compliance by the units. RIADA also agreed to arrange a demo of online payment on 03.02.18 for the benefit of members. On price of industrial land, he accepted it to be too high for MSMEs and asked JSIA to compile and submit land price of different Industrial areas of neighboring states. He agreed in principal to develop a Industrial park for MSMEs, for which department is looking for the big chunk of land.

On procurement policy he appraised that modification as sought have already been incorporated and notified.

On Electricity matter he informed that JBVNL has taken up installation of new transmission lines, for uninterrupted supply of power to all sectors. He assured that Industrial dedicated feeders would be made a reality soon.

He informed that by modifying the rules under MMDR Act-2015, Mining department has notified single registration in any district of Jharkhand for procurement of Minerals or Coal by MSMEs. Regarding policy of minor mineral he assured that it would be notified soon for auction of plots bearing minerals. Action to reopen closed mines of minor minerals through JSMDs would be considered. He asked to submit list of closed fire clay mines.

On pollution matter he agreed our suggestion that CTO should be graded at RO level and assured to initiate action on that. Issue of CTE/CTO on first come first serve would be taken up with JSPCB in next meeting.

Matter of framing a separate policy on Poultry farm & Hatchery attracts serious consideration, though it is under Animal Husbandry department. He assured to initiate action on the same and requested concerned member from Hazaribagh to compile & submit such policies from other states.

During question answer session he satisfactorily replied to most of the queries raised by members from different industrial areas viz. Tupudana, Namkom, Tatisilwai, Kokar, Adityapur, Ramgarh, Hazaribagh, Latehar, Palamu etc. The meeting was closed with vote of thanks by Sri Ranjit Tibrewal, PP

**Demo on online payment of rent by JIADA:**

**03.02.18:** In persuasion of the decision taken in the meeting held with Secretary Industries, Mines & Geology, at JSIA on 31.01.18, JIADA organized a Demo session at RIADA Building from 11:30A.M. to 1:30 P.M. on online payment of dues of land rent of Industrial units in different Industrial areas of RIADA. Mr. Akhilesh Sarukhia, Coordinator, EoDB, Industries department also gave Demo on Single Window portal, as to how members can file CAF and view statutory requirements for compliance under various Acts. Mr. Ajit Kr. Singh, RD, JIADA addressed the gathering and assured that in future there would be minimum interface with the office on such issues.

The meeting was called to take approval from the members on formation of Society named "Jharkhand Government Tool Room" by amalgamating five Tool rooms located in Ranchi, Dumka, Gola, Hazaribagh & Godda of Jharkhand, so as to govern all Tool Rooms by the Society in every respect. The discussion on Rules & Regulation of JGTR was held in the last Governing Board meeting, while MOU for JGTR was discussed & approved in the meeting.

**Meeting with M.S. JSPCB:**

**12.02.18:** Sri Philip Mathew & Sri Bikash Singh, PP, met Sri Rajiv Lochan Bakshi, newly appointed MS, JSPCB at 11:30 A.M. at his chamber and apprised him of the problem faced by the units to obtain their NOC, CTE & CTO. Matter of creation of additional High risk category under Orange category, in contravention of the guidelines of CPCB, New Delhi was also discussed. Having heard the issues with a positive mind set, Mr. Bakshi assured to take up the issue in next Board meeting and said that he would follow CPCB guideline. Unlike its predecessor, Mr. Bakshi seemed to act with a very positive attitude to resolve the issues.

**National Level Vendor Development Program by MSME-DI:**

**14.02.18 & 15.02.18:** Two days National level Vendor development cum Industrial Exhibition program was held at CMPDI, campus organized by MSME-DI in association with JSIA & other stake holders.

The inaugural program was held on 14<sup>th</sup> at 11.30 A.M. Sri K.Ravi Kumar, IAS, Director Industries was the Chief Guest and Sri Sekher Saran, CMD, CMPDI was the Guest of Honour. Sri Arbind Kumar, DGM, ONGC, Bokaro, Sri K.S.Rao, GMM, NMDC, Hyderabad, Sri T.P.Chopra, GM, MECON & President, JSIA shared the Dias, while Sri R.K.Kapoor, Director, MSME presided over the meeting & briefed about the program.

In their address all the speakers emphasized on implementing mandatory procurement of 20% by the PSU's from MSMEs under Procurement Policy-2012 and requested participants to attend their presentation after the inaugural session to get the benefit. The Director Industries in his address said that Govt. of Jharkhand has already uploaded draft on Make in Jharkhand (Purchase Preference) Policy -2018 and sought suggestion from the industries. Once it is implemented it would immensely help MSEs to develop. He also announced that GoJ has a target to employ 50K workers in the MSME sector within a year.

MSME-DI also felicitated our senior member, Sri Roshanlal Sharma, of M/s Tajna Sellac Pvt. Ltd., Khunti, who was present with his family members, by presenting a Shawl & Memento for his exemplary contribution towards industrial Growth. Sri Roshanlal Sharma also shared his experience in the journey of growth of his unit. A souvenir from MSME-DI was also released on the occasion.

The Industrial exhibition was formally opened by Director Industries, Sri Roshanlal Sharma and Sri Sekher Saran, CMD .The Dignitaries visited 74 stalls of various exhibitors and appreciated the products displayed there.

More than 8 members of JSIA also had put up their stalls in the Industrial Exhibition.

**15.02.18:** During the valedictory session the Chief Guest Dr. D.Ravishankar, Regional Chief, HUDCO in his address said that MSEs have been benefited in this program as they could interact with the officers of PSU's and could update their information about their requirement. **23.02.18:** A meeting was called by the Industries department, inviting all stake holders for obtaining suggestions on draft of Make in Jharkhand Purchase preference Policy-2018. Sri Deepak Kr. Maroo, V.P. and Sri Anjay Pacheriwala, Hony. Secretary attended the meeting at 11:00 A.M at Nepal house and submitted suggestion on various clauses of the draft policy for incorporation.

#### **Meeting of GST Advisory Committee:**

**26.02.18:** Sri Anjay Pacheriwala, Hony Secretary attended the meeting of GST Advisory committee at Project Building at 11:00 A.M.

#### **Press conference on Electricity tariff:**

**26.02.18:** President & Hony. Secretary attended a press conference jointly called by JSIA & FJCCI at their conference hall at Kadru more and lodged its protest against the petition filed by JBVNL for revision of electricity tariff defying the laws & procedure framed by JSERC.

Sri Ajay Bhandari, Sub committee chairman, Electricity from FJCCI emphasized that Nigam needs to control its irregularities of Power purchase , minimize Transmission & Distribution losses and improve its collection efficiency. If the above mentioned issues are addressed, there would not be any need to increase electricity tariff .

**Meeting of Electricity Advisory committee:**

**28.02.18:** President & Hony. Secretary attended Electricity Advisory Committee meeting at the conference hall of JBVNL, Dhurwa at 4.00 p.m. amidst other stake holders viz. FJCCI, ASIA, SPIA, SCCI, LUB, MECON, BIT, Mesra & others. Meeting was chaired by Sri Rahul Purwar, MD, JBVNL.

Detailed power point presentation was given by the department on their upcoming programs & planning under APDRP for augmentation of power in the state. The department has ambitious project of increasing transmission line, installing new sub stations, providing new Transformers & laying underground cables etc. Besides installing smart meters for the consumers & spot billing facilities. On-line grievance redressal system would also be in place from 1<sup>st</sup>.April'17. Mr. Rahul Purwar, MD, JBVNL assured that by the end of the year Nigam would be in a position to ensure 24/7 power in entire Jharkhand.

As it was first advisory meeting after a long gap, the discussion was mainly on modalities of meetings to be held at various level. Monthly meetings would be held at District level, and coordination committee meeting would be held once in every three months at Ranchi, JSR, Dhanbad, Deogher & Dumka & Daltangung. Next advisory committee meeting was decided to be held at Jamshedpur on 25.05.18.

**Regional Advisory Committee Meeting of CIPET:**

**05.03.08:** Sri Deepak Maroo, VP & Sri Jacob Mathew, both nominated from JSIA attended RAC meeting of CIPET at Project Building, Dhurwa. At 11.:00A.M. amidst other stake holders. The meeting was chaired by Sri Sunil Kr. Burnwal, Principal Secretary Industries cum Mines & Geology, GoJ. He said that the CIPET is established in May 2017 in Jharkhand with a view to impart training in skill development among the youths within its resources. In order to boost Make in India/ Digital India movement, there would be huge requirement of skilled youths in various sectors and CIPET can play a vital role in it. Proposal were placed to make CIPET a state level Nodal agency to impart training among youths in plastic processing & quality control. It was decided to hold RAC meeting every four months.

**Public hearing on Electricity Tariff:**

**07.03.18:** As per schedule last public hearing on electricity tariff was held at Aryabhatt Auditorium, Ranchi College from 11:00 A.M. onwards and continued for almost four hours. Sri R.S.Prasad, Chairman, JSERC chaired & presided over the hearing. Sri Rahul Purwar, MD, JBVNL presented comprehensive development plan of the Nigam and said that by the end of the year it would be in a position to supply uninterrupted power.

On behalf of JSIA Sri K.K.Poddar & Arun Khemka, PP, President, Hony. Secretary, VP, and few others lodged their protest and raised questions on revised tariff petition. As many as 29 participants including members of FJCCI, Furnace Association, Laghu Udyog Bharati, Tupudana Industries Association & general public vehemently objected the tariff petition on various technical as well as commercial grounds during the hearing and unanimously requested the commission not to consider any tariff hike.

The Chairman having heard all stakeholders directed JBVNL to upload their audited accounts of 2016-17 on the public domain and improve its efficiency so that consumers get quality electricity. He assured that he would certainly look into the interest of consumers before considering any hike in tariff.

**P.C.C. Meeting:**

**07.03.18:** Sri Ranjit Tibrewal, PP attended the PCC meeting at 11:00 A.M., held at JIADA, Namkom, chaired by MD, Sri Ajit Kr. Singh. Discussion on 50 Projects were held and baring a few all were cleared by the committee. Detailed report is as follows;

The Minutes of the previous meeting was confirmed and proposal on agenda was discussed to engage TVS Motor in setting up the training centre at Tool Room for training students to seek career in automobile field to learn & understand the skill/techniques required. MoU with TVS was finalized & approved by the members.

Besides installation of new Servo stabilizer to replace old UPS was also discussed and was approved, with a suggestion to make use of old UPS at other training centre.
