

SECRETARY REPORT FROM 21.12.2019 to 26.06.2020.

21.12.2019: Meeting with GM Cum Chief Engineer, JBVNL, Kusai, Doranda, Ranchi. Attended by Sri Anjay Pachariwala, Hony. Secretary.

Matters related to remission under Clause-13 LTIS Claim in Fixed Charges, payment of Interest on Security deposit, Billing matters etc were discussed.

08.01.2020: Meeting with Secretary Industries on 4th Gov. Council alongwith 1st AGM of Jharkhand Govt. Mini Tool Room, Attended by President, Sri Philip Mathew,

22.01.2020: Meeting of Controller of Examination in the chamber Director Employment and Training. JSIA being the Member of the Board, I have attended the Meeting in the Chamber of Director. Chief Inspector of Factories also in the meeting as the Member along with other members. Attended by Sri Randhir Kr. Sharma, Jt. Secretary.

The Committee has passed all the agenda mainly relating with the Publication of the Results of different semesters and years.

As any other matter, JSIA have raised as issue substantial reduction in the numbers of apprenticeships candidate in the state, for about 50% reduction in past years.

Also suggested the possible reasons like:

- Complex online registration, reporting, marking, payment etc. process, for appointment of apprentice.
- Resent changes in the policy.
- Sudden increase in the Stipend Amount.
- Reduces industrial activities in the state.
- We have suggested the committee should try find the other possible reasons and try for solution.

24.01.2020: A Workshop cum Interaction Session is being organized with Regional Provident Fund Commissioner, Ranchi regarding difficulties faced in online compliance by member units at JSIA.

13.02.2020: Meeting with Director of Industries on PMEGP attended by Jt. Secretary Sri Randhir Sharma. State Level Evaluation Meeting on MSME State Award'2019-20 and Award under PMEGP held on 13 Feb'2020.

MSME State Award:

The State award is under six category for Micro and Small industries and two award for Medium Industries. All together 4 application received from MSME of the state and evaluation has been done on the basis of standard format under various category.

Award Values along with certificate will be as follows:

First: Rs. 50,000.00 , Second : Rs. 40,000.00, Third : Rs. 25,000.00

The Initial cutoff date to apply was 27.08.2019 which has been extended till 27.10.2019. Only 4 applications have been evaluated which are being submitted within time.

From this year JSIA is also being the part of the Evaluation Team.

Following main criteria being followed:

1. Award given who have score 60 and above marks
2. One unit who have got award in that category will not get award again in 5 years.
3. Only certificate will be given for those unit who qualify in two category in the same year.

Award under PMEGP

All applications received and evaluated by the committee. 5 award for 1st, 2nd and 3rd prize to be given to 5 units in 5 divisions of Jharkhand.

On JSIA effort, from last year 1st, 2nd and 3rd Prizes are given in this category, earlier it was only 1st.

Dates for award for the Last year and Award for this year, yet to be decided.

Notices were being saved by EPF office claiming damages and Interest for delayed payment as old as 20 years. The statement being saved were erroneous and were insisting for presentation of records from our member units.

We had highlighted this issue at DG EPF Delhi, Hon'ble Labour Minister and PMO. Issues related to correction in data, mismatch with Adhar records etc were also discussed.

26.02.2020: Meeting with JSERC on State Advisory Committee. Hony. Secretary Sri Anjay Pacheriwala attended the meeting.

The issues raised and discussed were – Poor performance of JBVNL, non reliable data being submitted, billing and collection performance, non payment of Interest on Consumer Security deposit, Non billing of Solar Installations as per regulation, problem related to new connections.

We had been strongly pressing for access to Meter display at HT Consumer premises. JSERC agreed and directed JBVNL to ensure that all consumers have access to meter display reading.
