

**SECRETARY REPORT FROM 28.02.2019 to 25.04.2019.**

**28.02.2019:** President Sri S. K. Agrawal has attended a programme on “Technology Support and Outreach (TECH-SOP) organized by Ministry of MSME, Govt. of India through video conferencing held at NIC, Nepal House.

Objective of the programme is to sensitize the MSME fraternity about this role of new technology developed by various R&D Institutions in the country which are relevant for MSMEs for sustainable growth and can be made available on a cost effective manner.

On this occasion, an India Enterprises Portal was also launched. The purpose of the portal is to support the eco system for creation of entrepreneurship by providing guidance on various parameters for setting up the enterprises.

**19.03.2019:** Randhir Kumar Sharma, Jt Secretary has attended the meeting at the office of State Level Meeting on MSME State Award’2018 and Award under PMEGP held on 19 March’2019 under Chairmanship of Secretary Industries, Govt. of Jharkhand.

**MSME State Award:**

The State award is under six category for Micro and Small industries and two award for Medium Industries. All together 17 application received from MSME of the state and evaluation has been done on the basis of standard format under various category.

Award Values along with certificate is as follows:

First	:	Rs. 50,000.00
Second	:	Rs. 40,000.00
Third	:	Rs. 25,000.00

Following main criteria being followed:

1. Award given who have score 60 and above marks
2. One unit who have got award in that category will not get award again in 5 years.
3. Only certificate will be given for those unit who qualify in two category in the same year.

This year award to one unit was denied by the committee at Director's Level on the ground of NO CTO from Pollution Dept. The objection raised by JSIA on the self imposed new criteria by the department. The Secretary Industries have taken this in consideration and okay the name for Award to the unit.

**Award under PMEGP**

All together 82 applications received and 5 award for 1<sup>st</sup> prize to be given to 5 units in 5 divisions of Jharkhand.

Objection raised by JSIA and for giving only 1<sup>st</sup> Prize and NO 2<sup>nd</sup> and 3<sup>rd</sup> Prizes. In all the 5 divisions of Jharkhand. With the effort of JSIA now from this years in each division there will be 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Prizes will be awarded to PMEGP units of Jharkhand. This year committee has recommended names for 15 PMEGP units.
