10.06.2019: Public Procurement Policy and its Amendment meeting at MECON attended by Sri Keshav Chhawchharia, The details as follow:-

Minutes of the meeting with Sri S.K. Verma, GM, Contracts, Mecon India Ltd. on 10th June 2019.

- 1. Mecon is purchasing about 90-100 Cr per annum.
- 2. Mecon is regularly meeting and exceeding the regulation of 20% mandatory purchase from MSMEs
- 3. Mecon has not been able to meet the 5% SC/ST purchase criteria. It intends to increase its purchases from this category of MSMEs in the service sector:
 - a. Housekeeping
 - b. Courier Services
 - c. Transportation
 - d. Catering
 - e. Air Conditioner Maintenance
 - f. Guest House Maintenance
 - g. Electrical Maintenance etc.
- 4. Regarding non-preference of local industries in purchase, GM said that all MSME units are treated at par.

- 5. The issue of tender participation fees was raised. It was clarified that Mecon is not charging any amount for participation. However, the agency on whose website the tenders are being floated (i.e. www.tenderwizard.com) is in fact charging Rs. 3500 for participation. The GM was unsure of his influence over tender wizard, but assured that he would take up the matter.
- 6. Specific issues regarding LD with respect to MSEs were discussed. GM proposed a softer stance. In cases where delay in supply by MSE does not impact the project timeline, LD may not be deducted.

13.06.2019: 3rd Governing Council Meeting of MSME Tool Room was held at office of the Secretary Industries, Project Bhawan, Dhurwa, Ranchi. The meeting was attended by Sri S.K. Agrawal, President. Many suggestions were given by JSIA for further improvement and better institution & Industrial Partnership.
